# PREQUALIFICATION OF SUPPLIERS FOR THE FINANCIAL YEARS 2023-2025.

The Technical University of Kenya advertised the Prequalification in TUK website and PPIP on 20<sup>th</sup> April, 2023 for the Financial Years 2023-2025 with the intention of prequalifying suppliers in various categories.

The Ag Director Procurement and Supply Chain Management and the Chairman, briefed the Evaluation Committee on the procedures and requirements to be adhered to in the prequalification exercise.

An evaluation committee for Prequalification was duly appointed in line with the Public Procurement and Disposal Act, 2015 and Public Procurement and Disposal Regulations 2022, with a view to evaluate the suppliers who responded to the advertisement.



The Committee therefore recommended that the above sixty (60) bidders, be prequalified to supply for the Financial Years 2023-2025.
