AD HOC EVALUATION COMMITTEE REPORT ON TENDER No. TUK/T/06/2023/2024 SUPPLY OF TONER/CARTRIDGES, INKS AND RIBBONS.

1. PREAMBLE

1.0 Overview

The Ad-Hoc Evaluation Committee (EC) which was duly appointed by the Vice-Chancellor in accordance with the Public Procurement and Regulatory Authority Act, 2015 (PPRA) was mandated to evaluate and recommend the highest evaluated bidder for award of the contract to supply the University with Toner, Cartridges, Inks and Ribbons TUK/T/06/2023/2024.

1.1 Scope of Work

• Evaluate and recommend the most suitable supplier for the tender in accordance with the Public Procurement Regulatory Authority (PPRA) Act 2015.

1.2 Evaluation Duration

• The Act provides for a period of not more than thirty (30) days from the close of the tender which should be on or before June 10th 2023.

2. PRELIMINARIES

2.1 Preamble

The Chairman invited the Acting Director, Procurement and Supply Chain who is the coordinator of the institution's evaluation committee to give a brief background of the process from inception to the evaluation stage. The Coordinator informed the committee that the process begun with the Tender advertisement through the website on 20th April 2023 and closed and opened on the 10th May 2023 by the tender opening committee in the presence of bidders. The Tenders were to be opened on 3rd May 2023 but there was addendum and so there was seven (7) day extension of the opening date of Tenders.

The director emphasized the need to stick to the procurement regulations to meet the tender processing deadline of twenty-eight days from the date of opening.

The coordinator set the pace of evaluation by outlining the steps of the process as mandatory, technical and financial evaluation. A bidder who is not responsive to any one of the proceeding requirement does not proceed to the next. A pass 60 marks must be attained in the technical evaluation to qualify for the financial evaluation. After the financial evaluation the highest/ most successful bidder will then be subjected to due diligence visit to corroborate the facts as presented by the tenderer.

3.0 EVALUATION:

The committee started the evaluation process for Tender No. TUK/T/06/2023/2024 Supply and Delivery of Toner/Cartridges and Ribbons Twenty (20) bids were, presented by the Tender opening committee. The bids were randomly serialized from one (1) to twenty (20).

The committee was duly presented with a copy of the tender opening committee minutes for purposes of confirming the accuracy and validity of the tender booklets as presented by the opening committee. The bids were conveniently tied into two bundles not in any particular order for ease of carrying.

The Chairman let the committee into picking of evaluator numbers that will be used during the period of evaluation to conceal the identity of the individual evaluators, this process was done by way of random balloting and the numbers assigned as in table 1.

3.1. Mandatory Evaluation:

The committee started to evaluate Tender No. TUK/T/06/2023/2024 Supply and Delivery of Toner/Cartridges and Ribbons, The committee used the check-list derived from the tender document to determine the responsiveness of the bidders. Table 2 shows the outcome of the mandatory evaluation.

- 1. B1 did not provide three years Audited financial statement and the financial documents should be signed by the auditor for ownership of the report.
- 2. B2 did not attach the audited financial statement.
- 3. B3 There was anomaly in the two financial year statement, having the same amount i.e. Net liability of the year 2020 and 2021 reads the same.
- 4. B4 did provide the statement of change in equity and note in number 11, and 12 have, no explanation for us to understand.
- 5. B5 audited books has not been signed by the auditing firm to own the report.
- 6. B7 did not attached copy of current single business permit.
- 7. B8 the director signature and date are available but has not been stamped for authenticity and for the books of account this must be done.
- 8. B11 did not provide tax compliance certificate and Pin certificate also expired. There is no ownership of financial statement
- 9. B12 Auditors stamp is not clear; the auditor has not owned the financial statement by signing and stamping it.
- 10. B14 did not provide single business permit
- 11. B15 The audit firm did not own the financial statement by signing it secondly the firm only provide two years audit report instead of three.
- 12. B16 the stamps by auditor report has different font size for the year December 2022 and December 2021. No stamp of auditing firm.
- 13. B17 There is no ownership of financial statement by the auditor.
- 14. B18 There is no ownership of the financial statement by the auditing firm.
- 15. B20 did not provide two copies of the Tender document, only one was available and did not provide current business permit.

*On the completion of the mandatory evaluation, five (5) bidders qualified for the technical evaluation as is presented in Table 2 above.

3.2 Technical Evaluation

The committee used the set check-list in column 2 of Table 3 that was derived from the tender document to determine the responsiveness of the bidders.

The committee noted that the technical evaluation on requirement number six (6) was not clear to the tenderers since all bidders score zero in this column. Three (3) Bidders qualified to proceed to the financial evaluation after attaining the set out pass of **60** marks and above out of a possible maximum of **80**.

The following Two bidders did not attain sixty percent (60% pass mark)

- **1.** B6.
- **2.** B9.

Three bidders were: B10, B13, B19, were then subjected to analysis by way of price comparison.

4.0 Financial Evaluation

Three bidders were allowed to proceed to financial evaluation stage having been cleared to have genuine and reasonable audited accounts. These were bidder number, B10, B13 and B19.

The committee unanimously agreed to subject the two bidder to due diligence before recommending the successful ones for award of the tender.

Therefore the two bidders, B10 and B19 proceeded to due diligence evaluation stage.

5.0 Due diligence.

The committee carried out a due diligence study on the two prospective bidders using the check-list in table 5 and came up with the following observations;-
